#### Consultation Summary: Malvern Hills National Landscape Guidance on Lighting

PLEASE NOTE: On 22 November 2023, the Malvern Hills Area of Outstanding Natural Beauty (AONB), was rebranded as the Malvern Hills National Landscape. National Landscapes are designated AONBs. For the purposes of this consultation summary, reference is made to the Malvern Hills AONB Unit when work was undertaken prior to re-branding, and the Malvern Hills National Landscape Team for work following re-branding.

# Purpose of this summary

This note details the steps taken by the Malvern Hills National Landscape Team to consult others on an updated guidance document relating to Lighting within the Malvern Hills National Landscape. The guidance stems from a previous publication on Lighting Guidance by the Malvern Hills AONB Partnership.

## **Pre-Consultation**

This document builds on work originally published in 2019 and aims to add technical value to the existing document. An updated draft guidance document was compiled by a lighting consultant, Dan Oakley of Darkscape Consulting, in early 2023, with further input from Malvern Hills AONB Unit staff subsequently.

#### Consultation

This guidance document was consulted on at the same time as the following draft documents: Position Statement 2: Housing Development in the Malvern Hills National Landscape and its Setting, Position Statement 3: Landscape-led Development, and Guidance on Horse-related Development.
